COVID safety guidelines + Rules of Conduct/Policies and Procedures for KLSC

1. Only **one** parent/guardian allowed in the arena per skater
2. Skaters and parents must enter through the back entrance, by the skate sharpening room, and exit through the back door (hockey door—ice show door)
3. COVID questionnaire to be filled out by parents **and** skaters upon entering the arena **every session**
4. Masks to be worn at all times unless on the ice
5. For Parent and Tot session, parent must be able to skate and assist their skater on their own (due to social distancing guidelines coaches will not be “hands on” with skaters)
6. For Canskate & Parent and Tot sessions, skates can be put on in the assigned dressing room or in the stands, social distancing guidelines will be in place.
7. Parents are not permitted on the ice surface during KLSC sessions. (unless registered with Skate Canada, ie Parent and Tot)
8. CSA Approved Hockey Helmets are mandatory for Parent and Tot and Canskate Sessions.
9. Skaters must wait until the Zamboni has left the ice and the Zamboni Doors are closed and a Coach, Executive Member or a Program Assistant is present before stepping onto the ice.
10. Skaters are to leave the ice surface immediately when the bell rings or when asked to by a person with authority.
11. Water only, on the ice, at the boards, or in the area of the players’ benches.
12. Gum is not to be chewed on the ice.
13. Cell phones for the purpose of making calls or texting are not permitted on or near the ice surface, or at the players’ benches. Calls and texts should be done **before and after sessions**. Cell phones and other electronic devices being used for the following purposes **are** permitted on or near the ice surface: videotaping practices, listening to solo, dance or other music, provided that for safety only one ear bud is being used.
14. Proper skating attire must be worn at all times. Clothing must allow for easy movement. Clothing that restricts movement (ie: tight jeans) and extremely low-cut female tops are not appropriate.
15. Be respectful to all fellow skaters and all coaches, on and off the ice. Activities such as bullying, swearing, and gossiping will not be tolerated.
16. Do not ask to see a coach when she is teaching lessons, running the warm-up or setting up circuits
